<u>A5 – REGULATIONS</u>

These Regulations must be signed together with the booking contract.

A5.1 - Withdrawal of the Exhibitor and Penalty for the withdrawal The Exhibitor will have the right to withdraw from participation by notifying it by certified e-mail or e-mail with reading acknowledgment by 1st October 2023. The amount paid will be returned to the Exhibitor by that date. From 2nd October 2023 to 5 March 2024, in case of exercise of the right of withdrawal, the Registration Fee and the Advance Payment will be retained as a penalty. After 5 March 2024, the Exhibitor will not be able to withdraw, therefore, in the event that he communicates his nonparticipation, he will be required to pay the entire amount contractually due as a penalty, as well as to indemnify LIFT EXPO ITALIA SRL for the damages the same should suffer as a result of the renunciation. In both cases of non-participation, LIFT EXPO ITALIA SRL reserves the right to proceed with the assignment of the stand to another Exhibitor, without this possible subsequent assignment precluding or limiting its right to request penalties in the measures indicated above.

A5.2 - Exhibition space reductions

Before the notification of stand assignment, if the Exhibitor intends to reduce the exhibition area initially booked at the time of registration for the Expo, the deposit paid for the square footage which is cancelled, is forfeited by LIFT EXPO ITALIA SRL as reimbursement of organizational expenses. If the request for reduction of the exhibition area is after $5~{\rm March}~2024$, the Exhibitor will be obliged to pay the total amount of the assigned area.

A5.3- Digital Catalogue and Promotional Materials

LIFT EXPO ITALIA SRL will insert the company names, data and location of the Exhibitors in the official Expo catalogue, on the website and in the promotional material it deems appropriate without this implying any responsibility for the contents, any omissions and/or o errors in the printing of promotional materials (e.g.: publications, exhibition signs, etc.) and in the dissemination of said catalogue.

A5.4 - Prohibition of Assignment

The notification of assignment of the exhibition area is valid for the Exhibitor to whom it is made out. The total or partial transfer, even free of charge, of the assigned Exhibition Space is prohibited (whether by way of transfer of the contract or sublease or otherwise). LIFT EXPO ITALIA SRL also reserves the right to proceed with the immediate closure of the exhibition space sold with charges to both companies that have lent themselves to the sale, jointly and severally.

A5.5 - Force Majeure and Cancellation

In the event that a cause of force majeure occurs, meaning unpredictable events that make it impossible to hold the Expo and/or in any case for reasons not attributable to LIFT EXPO ITALIA SRL, the same may change the date of the Expo and/or cancel the Expo in whole or in part.

A5.6 - Processing of Exhibitor's Personal Data

- The Exhibitor declares to be informed that the provisions of Regulation (EU) 2016/679 General Regulation on the Protection of Personal Data (hereinafter the "RGPD" or "GDPR") concern the processing of data relating to natural persons
- The Personal Data referring to the Exhibitor, where operating as an individual company, small business owner or professional, as well as referring to the representatives, exponents, employees and collaborators of the Exhibitor indicated in the Application form are collected and processed by LIFT EXPO ITALIA SRL as Data Controller in the terms described in the information pursuant to art. 13 Regulation (EU) 679/2016 General Data Protection Regulation ("RGDP" or "GDPR")
- The Exhibitor undertakes to communicate this Information to the natural persons (its representatives, representatives, employees and collaborators) to whom the Personal Data provided for the purpose of participating in the Expo and the provision of related services refer, as well as guaranteeing that the Personal Data can be lawfully used by the Owner for these purposes and to hold harmless and/or indemnify the Owner for any cost or damage deriving from the violation by the Exhibitor of the obligations assumed pursuant to this article towards the Owner

A5.7 - Complaints, applicable law and competent court Any complaints must be presented in writing to LIFT EXPO ITALIA SRL The applicable law is Italian law and for any dispute relating to, or in any case connected to the Application, the Court of Milan is exclusively competent to judge.
